Dear Representatives Tiberi and Larson:

We, the undersigned organizations of consumer and disability advocacy groups, would like to thank you for introducing bipartisan legislation, the Medicare DMEPOS Competitive Bidding Improvement Act of 2014/HR 4920.

Medicare's current bidding process restricts access to, and choice of, medical equipment products and services by forcing individuals with significant disabilities, the chronically ill and the frail elderly to use certain medical equipment providers whether they furnish the products and services that provide the most benefit to consumers or not. By limiting the choice of medical equipment providers, people with disabilities are experiencing increased difficulty getting appropriate wheelchairs, repairs and other medical equipment, support services, and much needed medical supplies. This process has greatly increased the occurrence of delivery delays, incidents of wrong products and parts delivered, and it has created hardships for people with disabilities who are now forced to use providers that are far from their homes both in and outside their state of residence.

United Spinal and other consumer and disability groups have heard of many instances where durable medical equipment companies do not have the expertise in providing wheelchairs or other medical equipment such as oxygen and oxygen supplies to individuals with disabilities who are on Medicare and they are not licensed to furnish the type of equipment for which they have received a contract from the Centers for Medicare and Medicaid Services (CMS) to provide to those individuals. United Spinal and other stakeholders are also aware of companies that are currently allowed, under Medicare regulations, to not be bound by the CMS contract of providing services and equipment that they have been offered – meaning that they are not required to provide services and equipment contained in the contract at the CMS reimbursement rate. This leaves many individuals with disabilities who rely on durable medical equipment to continue their independence and engage in their community without any options to have access to trusted, qualified and experienced durable medical equipment providers.

The Medicare DMEPOS Competitive Bidding Improvement Act of 2014/HR 4920 will add badly needed provisions to improve the poorly designed bidding program by requiring that participating durable medical equipment suppliers comply with state licensure requirements and binding bids to ensure that access to quality equipment and services is protected. This means that participating suppliers must agree to all pertinent state licensure requirements, be bound to the accepted CMS contract and provide equipment and services to their customers at the contracted rate.

Thank you again for introducing HR 4920 which will reform Medicare's current bidding program through state licensure requirements and durable medical equipment company performance bonds to ensure that individuals with disabilities receive high-quality service and equipment that will give our community the ability to live active, productive independent lives with improved health outcomes.
